Dear Western PA High School:

The Western Pennsylvania Trial Lawyers Association (WPTLA) is pleased to extend an invitation to your school district's seniors to compete for three \$2,000.00 scholarships to be awarded in May 2024. This invitation is being extended to public and private high schools in the Western District of PA. The student whose essay is submitted must reside within one of the 26 counties that comprise the Western District of PA, as defined by the United States District Court. The scholarships will be awarded based upon an assessment of essays submitted by the participating school districts.

For this year's scholarship essay contest, students will be asked to argue their position on a First Amendment case concerning trademark restrictions on the use of names of living politicians or famous people without their consent.

Each school district is invited to select one senior student's essay for submission to WPTLA. The essays are to be three to five pages double spaced. The WPTLA Scholarship Essay Committee will select three winning essays from all of those submitted. Each of the three winners will receive the Western Pennsylvania Trial Lawyers Association's President's Scholarship, consisting of a \$2,000.00 award. Each winner will be invited, along with two guests, to attend the WPTLA's Annual Judiciary Dinner on a Friday in May 2024 in Pittsburgh where the awards will be presented. The winners and their two guests will receive complimentary tickets to the Judiciary Dinner where, in addition to the WPTLA lawyers, there will be many judges from the Western District of Pennsylvania in attendance.

Information packets containing more details and the rules of the Scholarship Essay Contest will be available for distribution upon request. Packets will only be sent by WPTLA to those schools – not students – who respond that they wish to participate in the Contest and complete the Request for Information form. All correspondence during the contest must be between the representative of the school district and WPTLA, and not between students and WPTLA. **Additionally, the packets of information are for your school only. They are not to be shared with other schools, either by duplication or by posting on your school's website. If you become aware of another school that you think should participate, please contact me and I will handle the details.**

To receive the information packet, please complete the enclosed Request for Information form and return it to me before Friday, January 19, 2024. If you will be sending your request via email, please contact your email administrator to accept email messages from laurie@wptla.org.

Information packets will be distributed by January 26, 2024, to those schools who submit a Request for Information form. Please make copies for all students who may be interested in entering the contest. **Only one entry will be considered from each school district.** Each school district, therefore, will select its best essay for submission. Your school district's essay must be postmarked/date-stamped and sent on or before Friday, March 22, 2024, to be considered. Late submissions will be disqualified.

If you have any questions concerning the Scholarship Essay Contest that are not answered by this letter, please feel free to call or email me for additional information, using the contact information above. We, at WPTLA, are very enthusiastic about this opportunity to recognize outstanding high school seniors and participate in their continuing education.
