Title I School-Level Family Involvement Policy

The Gateway School District recognizes the importance of a positive school-family relationship and the positive impact it has on student achievement. Therefore, we have developed a written Title I parental involvement policy with input from parents. During the first Family Teacher Organization meeting in the fall:

- Title I budgetary items are disclosed and discussed with parents;
- Title I processes are explained, "School-Wide Model" vs. "Pull Out" program
- Features of the School Wide Model are explained: All students receive interventions as needed, All teachers are considered Title I teachers, All students are considered Title I students.
- Compliance mandates in acceptance of Title I funds

The policy describes the means for carrying out the following Title I parental involvement requirements.

Involvement of Parents in the Title I Program: To involve parents in the Title I program in the Gateway School District the following practices have been established:

- The school offers meetings for Title I parents.
